ELECTION RULES 2026-2028

It is circulated for information that in the Executive Committee meeting dated 19-06-26 it was approved to announce Election schedule for the year 2026-2028 within following frame work: -

- 1- The election for ten vacant seats of Executive Committee will be held (four for Southern Zone & six for Northern Zone). The Executive Committee so completed will elect one Chairman and two Vice Chairmen (One from Southern zone & other from Northern zone) from among themselves.

Note: - Northern zone means the province of Punjab, Khyber Pakhton Khwah and Islamabad Capital Territory whereas Southern zone means the province of Sind & Balouchistan.

- 2- Mr. Muhammad Mahboob Alam, Secretary General, has been appointed Returning Officer for the election 2026-2028. All the election correspondence shall, therefore, be addressed to him on the following postal address: -

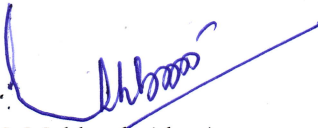

- 3- All the election correspondence shall be dispatched through registered post or courier service so as to reach on the scheduled date. No ordinary mail shall be entertained.

- 5- If nominations forms are received seat by seat and candidates are unanimously decided for the vacant ten seats of Executive Committee then there will be No election. However, the Executive Committee will elect one Chairman, two Vice Chairmen among themselves.
- 6- Timing for election proceedings shall be 9:00 am to 4:00 pm daily except Friday where timing will be 9:00 am to 1:00 pm. Sunday will be closed.
- 7- The form of nomination as per enclosed specimen after completion be dispatched so as to reach latest by 17-08-2026 (after noon) for member Executive Committee and for Chairman/Vice Chairman latest by 19-09-2026 (after noon). The nomination forms for Chairman are to be filed from Southern Zone only being the turn of Chairman. Incomplete forms or wrongly filled shall be rejected.
- 8- The members who are defaulters of the Association in any respect shall not be eligible to contest for any position or to cast their vote. Section 15(d) of Articles of Association duly approved by DGTO refers which quotes **"No member shall be entitled to vote at any meeting or association unless all moneys due on account of membership fee or otherwise have been paid to the association by the due date"**. Further, such defaulters shall also not be eligible to propose or second any contesting candidate for Election 2026-28.
- 9- The final announcement of results of election shall be made in the General Body meeting on 30-09-26 and induction of elected members in their respective offices shall also be made on the same day.
- 10- The members of Election Commission shall not be eligible to contest the Election. However, they will be entitled to cast their vote.
- 11- Members of the Executive Committee completing their two years tenure as on 30-09-2026 shall automatically stand retired on the date.
